4. President's Report (Jon Roe)

- a. Dues Increase
 - i. Per CCRs Article IV.3.b the Board can impose up to a 7% increase in dues per property.
 - 1. The annual assessment for the fiscal year following the Commencement Year, and for each fiscal year thereafter, shall not be increased from the annual assessment for the procoding fiscal year by more than Seven Percent (796).
 - ii. All board members approve dues increase effective January 1,

2024. Each TPS homeowner's quarterly dues will be \$278.

- 1. The additional \$4,392 generated from the increase in dues will be added to our snow removal budget. This will allow us to properly plow the neighborhood and keep our roads safe.

- a. Snow Removal
 - i. Wes Ichesco presented 9 quotes from various snow removal vendors
 - ii. Choice came down to Superior Landscaping, Boswell Landscaping, and CPM. All other vendors were out of range for budget, or did not offer per plow pricing.

- iii. All board members approve Boswell due to competitive pricing and good reviews.
 - 1. \$2454 per plow with salt, \$2204 per plow without salt
 - a. Old pricing with DK Services: \$1645 per plow with salt, \$1470 without salt
 - 2. Driveways and roads
 - 3. 3 inch plow trigger
- b. Fence on Textile: Wes will replace 10 boards. Lee's Outdoor Services will dispose of old fence rails.
